SUBJECT: Revisions to instructions on Parts of the Bible (6.23.2.9.2-6.23.2.9.5 and

6.23.2.9.7)

The text below reflects the decisions made by the Joint Steering Committee during its November 2014 meeting and via email after the meeting. The changes to the first paragraph of 6.30.3.2 are from 6JSC/ALA/34/rev/Sec final. Some of the revisions in appendix E represent changes from 6JSC/MusicWG/4/rev.

This document was revised to clarify the extent of the Alternative in 6.23.2.9.5.2 and correct some typographical errors. Revisions from this proposal and revisions from various proposals in previous years not made in E.1.1 were added there.

# 6.23.2.6 Apocryphal Books

An apocryphal book is one that is neither in the Catholic canon nor in the Protestant Apocrypha (see 6.23.2.9.4). Choose as the preferred title for an apocryphal book the title commonly found in reference sources in a language and script preferred by the agency creating the data.

# 6.23.2.9.2 Books

For a book of the Catholic or Protestant canon, record the title preferred by the agency creating the data (see the listing of books on the Tools tab of RDA Toolkit: **Books of the Bible**). Record the title as a subdivision of the preferred title for the Bible.

#### **EXAMPLE**

Bible. Ezra

Preferred title recorded by an agency using the Authorized Version Bible

Bible. Revelation

Preferred title recorded by an agency using the New International Bible

Bible. Baruch

Preferred title recorded by an agency using the New Jerusalem Bible

**EXAMPLE** 

Bible. Corinthians, 1st

Preferred title recorded by an agency using the Authorized Version Bible

Bible. Samuel, 2nd

Preferred title recorded by an agency using the New International Bible

Preferred title recorded by an agency using the Douai Bible

For apocryphal books outside of the Catholic canon or Protestant Apocrypha, see 6.23.2.6.

For a single selection from an individual book, see 6.23.2.9.5.

For other selections from the Bible, see 6.23.2.9.7.

# **6.23.2.9.3 Groups of Books**

For a group of books, record the title preferred by the agency creating the data (see the listing of books on the Tools tab of RDA Toolkit: **Books of the Bible**). Record the title for the group as a subdivision of the preferred title for the Bible.

**EXAMPLE** 

Bible. Pentateuch

Preferred title recorded by an agency using the Authorized Version Bible

For other groupings of books of the Bible not covered by this instruction, apply these instructions, as applicable:

two or more complete selections from the Bible (see 6.23.2.9.6) other selections from the Bible (see 6.23.2.9.7).

# 6.23.2.9.4 Apocrypha and Deuterocanonical Books

For an individual book of the Protestant Apocrypha or a deuterocanonical book of the Catholic canon, see 6.23.2.9.2.

For the group of books known as the Protestant Apocrypha or the deuterocanonical books of the Catholic canon, see 6.23.2.9.3.

Do not treat an edition of the Bible lacking these books as being incomplete.

For apocryphal books that are not part of either the Catholic canon or of the Protestant Apocrypha, see 6.23.2.6.

# 6.23.2.9.5 Single Selection from an Individual Book

For a single selection from an individual book of the Bible, apply the following instructions, as applicable:

single selection identified by title (see 6.23.2.9.5.1) single selection identified by numeric designation (see 6.23.2.9.5.2).

# 6.23.2.9.5.1 Single Selection Identified by Title

If a single selection from an individual book of the Bible is commonly identified by its own title in reference sources in a language preferred by the agency creating the data (rather than its designation as part of the Bible), record that title directly as the preferred title.

## **EXAMPLE**

Lord's prayer **not** Bible. Lord's prayer **not** Bible. Matthew, VI, 9–13

Ten commandments **not** Bible. Ten commandments **not** Bible. Exodus. Ten commandments

**Variant titles.** Record as a variant title (see 6.23.3.5) the preferred title for the book followed by the chapter and verse (see 6.23.2.9.5.2).

#### 6.23.2.9.5.2 Single Selection Identified by Numeric Designation

If

the resource being described is part of a book  $\ensuremath{\mathit{and}}$ 

it is not a single selection identified by its own title

then:

add the chapter (in roman numerals) and verse (in arabic numerals).

Use inclusive numbering if appropriate. Use commas to separate the name of the book, the number of the chapter, and the number of the verse or verses.

#### **EXAMPLE**

Bible. Psalms, VIII

Preferred title recorded by an agency using the Authorized Version Bible

Bible. Corinthians, 1st, XIII, 12

Preferred title recorded by an agency using the New International Bible

Bible. Ecclesiastes, III, 1-8

Preferred title recorded by an agency using the New Revised Standard Version Bible

Bible. Josue, IV-XIV

Preferred title recorded by an agency using the Douai Bible

Bible. Genesis, XI, 26-XX, 18

Preferred title recorded by an agency using the Authorized Version Bible

# Alternative

If:

the resource being described is part of a book and

it is not a single selection identified by its own title then:

add the chapter and verse using numerals in the form preferred by the agency creating the data.

Use inclusive numbering if appropriate. Use punctuation in the form preferred by the agency creating the data to separate the name of the book, the number of the chapter, and the number of the verse or verses.

#### 6.23.2.9.6 Two or More Complete Selections from the Bible

#### 6.23.2.9.7 Other Selections from the Bible

Apply this instruction to

selections from both the Old Testament and the New Testament selections from a testament selections from an individual book excerpts from a single selection from an individual book selections from a group of books.

Do not apply this instruction to an inclusive selection from an individual book identified by numeric designation. Apply instead the instructions at 6.23.2.9.5.2.

Record the most specific title that is appropriate for the selections, followed by the conventional collective title *Selections*.

Record the specific title for the part or parts by applying these instructions, as applicable:

Testaments (see 6.23.2.9.1) books (see 6.23.2.9.2) groups of books (see 6.23.2.9.3) single selection from an individual book (see 6.23.2.9.5) two or more complete selections from the Bible (see 6.23.2.9.6).

#### **EXAMPLE**

Bible. New Testament. Selections

**Resource described:** The records and letters of the apostolic age : the New Testament Acts, Epistles, and Revelation in the version of 1881 / arranged for historical study by Ernest De Witt Burton

Bible. Gospels. Selections

**Resource described:** The message of Jesus Christ: the tradition of the early Christian communities / restored and translated into German by Martin Dibelius; translated into English by Frederick C. Grant. **Preferred title recorded by an agency using the Authorized Version Bible** 

Bible. Genesis. Selections

**Resource described:** The story of the creation: words from Genesis. **Preferred title recorded by an agency using the Authorized Version Bible** 

If a specific title for the part is not applicable, record *Bible*, followed by the conventional collective title *Selections*.

**EXAMPLE** 

Bible. Selections

**Resource described:** Memorable passages from the Bible (Authorized Version) / selected and edited by Fred Newton Scott

## 6.23.2.12.3 Separately Published Components

For a separately published component of the *Midrash ha-gadol*, *Midrash rabbah*, or *Sifrei*, record the name of the book of the Bible with which it deals. Record the name of the book of the Bible (see 6.23.2.9.2) as a subdivision of the preferred title for the midrashim.

**EXAMPLE** 

Midrash ha-gadol. Numbers

Precede a designation and/or title for a part or parts of a work by a full stop and a space.

Precede the conventional collective title *Selections* by a full stop and a space.

Precede the terms *Libretto*, *Librettos*, *Lyrics*, *Text*, and *Texts* by a full stop and a space.

Enclose these elements in parentheses:

form of work
date of work
place of origin of the work
other distinguishing characteristic of the work
other distinguishing characteristic of the expression.

When multiple elements are enclosed in parentheses, separate them with a space, colon, space.

Precede these elements by a full stop and a space: content type date of expression language of expression.

Precede the medium of performance by a comma and a space.

Enclose the number of parts or players in parentheses.

Precede the term *arranged* by a semicolon and a space.

Precede the terms *Vocal score*, *Vocal scores*, *Chorus score*, and *Chorus scores* by a full stop and a space.

Enclose an other distinguishing characteristic of a musical expression (except *arranged* and *Vocal score*, *Chorus score*, etc.) in parentheses.
