The JSC established the FastTrack process for correction of typographical errors, addition or removal of examples, addition of terms to vocabularies, addition of references, clarification in wording, etc. The possible changes are discussed by the JSC representatives, not by the JSC constituencies. If a JSC representative thinks a possible change should be discussed by the JSC constituencies, the entry for that change is removed from the FastTrack process.

- a) the relationship between a work and an expression through which that work is realized and the reciprocal relationship from the expression to the work
- b) the relationship between an expression of a work and a manifestation that embodies that expression and the reciprocal relationship from the manifestation to the expression
- c) <u>the relationship between a manifestation and an item that exemplifies</u> <u>that manifestation and the reciprocal relationship from the item to the</u> <u>manifestation</u>.

For practical purposes we may also declare a relationship and its reciprocal between a work and a manifestation with an implied expression. In such cases, the expression is understood to exist, but is not identified explicitly.

This chapter also provides <u>both the</u> general guidelines and <u>specific</u> instructions on the use of identifiers, authorized access points, and composite descriptions to record primary relationships. <u>recording primary relationships</u>:

- a) It sets out the functional objectives and principles underlying the guidelines and instructions on recording the primary relationships.
- b) It specifies the core elements required to meet the functional objectives.
- c) It provides instructions on recording the primary relationships by using identifiers, authorized access points, and composite descriptions (17.4.2, 17.5-17.12).¹

¹Some encoding standards may not have a design that is suitable for recording the primary relationships. In these cases, primary relationships are not explicitly recorded though they may be inferred from other data elements in composite descriptions.

A code identifying the region of the world for which a DVD videodisc has been encoded and preventing the disc from being played on a player sold in a different region.

Glossary, Scale Differs [new entry]:

Scale designation for a resource consisting of more than one image, map, etc., with different scales.

Glossary, Scale Not Given [new entry]:

Scale designation for a resource when no scale can be determined.

Glossary, Scale Varies [new entry]:

Scale designation for a resource whose scale is variable across the resource, when the range of values cannot be determined.

Glossary, Semiannual [new entry]:

Frequency for a resource issued or updated twice every year.

Glossary, Semimonthly [new entry]:

Frequency for a resource issued or updated twice every month.

Glossary, Semiweekly [new entry]:

Frequency for a resource issued or updated twice every week.

Glossary, Service Copy [new entry]:

Generation designation for a microform resource made from another microform that is intended primarily for use. Also known as a reference or use copy.

Glossary, Short Stories [new entry]:

Conventional collective title for compilations of all short stories by a person, family, or corporate body.

Glossary, Silent [new entry]:

Sound content for a motion picture or video recording that does not contain a sound track.

Glossary, Sound [new entry]:

Sound content for a resource that contains sound, other than one that consists primarily of recorded sound.

Glossary, Speeches [new entry]:

Conventional collective title for compilations of all speeches by a person, family, or corporate body.

Glossary, Stamper [new entry]:

Generation designation for an audio recording comprising a hard metal negative copy of a disc master that can be mounted within a press and used to impress the groove pattern in a production run of discs.

Glossary, Standard [new entry]:

Groove characteristic for an analog cylinder with a groove pitch of 40 turns per cm (100 turns per inch).

Glossary, Tape Duplication Master [new entry]:

Generation designation for an audio recording comprising a tape copy (usually a first generation copy of the master) used for creating multiple copies of the content (e.g., for compact cassettes).

Glossary, Test Pressing [new entry]:

Generation designation for an audio recording comprising one of a short run of pressings used to check for any flaws before running a full pressing. The term is ambiguous because it is also used to refer to initial pressing sent out to reviewers, DJs, etc.

Glossary, Three Times a Month [new entry]:

Frequency for a resource issued or updated three times every month.

Glossary, Three Times a Week [new entry]:

Frequency for a resource issued or updated three times every week.

Glossary, Three Times a Year [new entry]:

Frequency for a resource issued or updated three times every year.

Glossary, Triennial [new entry]:

Frequency for a resource issued or updated once every three years.
